I am Associate Professor of strategic management at the Melbourne Business School. My research explores the strategies used by organizations to manage inventors, scientists, designers and the knowledge they create. I joined Melbourne Business School in 2006, where I have taught the core MBA Business Strategy course for over a decade. I created the MBS Innovation Bootcamp and co-founded the Melbourne BioDesign course. I also created the capstone project course for the Master of Entrepreneurship program at the Wade Institute, University of Melbourne. Apart from that I have taught Business Tools for M.Sc students and led PhD seminars. I have also conducted numerous workshops and mentoring sessions for teams working on innovation projects. These include startup teams at the Melbourne Accelerator Program, MAP Velocity Program, Translating Research at Melbourne program, Wade Institute for Entrepreneurship, and various accelerators and corporate innovation teams. I have served as co-director and board member of the Intellectual Property Research Institute of Australia (IPRIA.ORG) and as the MBS representative on the Business Council of Australia Innovation Task Force.
